Open letter to António Guterres

Swiss Citizens' Concerns Regarding the Pact for the Future

Dear Secretary-General Guterres,

This September, the 79th General Assembly of the United Nations will convene the "Summit of the Future," where member nations should sign the "Pact for the Future." We, the Swiss Sovereignists, view this step as pivotal towards creating a global governance system driven by SDG - artificial intelligence (AI).

The summit, scheduled for September 22-23, 2024, in New York City, has been officially prepared since 2022 in order to redirect financial resources from ordinary taxpayers to wealthy billionaires and their capital pools (the financial oligarchy), aiming to achieve the 2030 Agenda goals adopted by the UN in 2015. Notably, Swiss citizens have never been consulted about whether we want to support the 2030 Agenda goals or not. And we don't.

The anticipated highlight of this year's summit is obviously the signing of the Pact for the Future. Because our Swiss representatives at this summit meeting have never sought for a public discussion about this pact and the underlying agenda with the Swiss citizens, they won't be able to give you our own feedback. For this reason we take the liberty of expressing our opinion directly to you.

Today as we celebrate our Swiss National Day, we would like to state clearly and unequivocally: this is by no means OUR Common Agenda or OUR Pact for the Future. We do not feel the need for a new "Social Contract" with the United Nations that would subordinate our lives to AI either.



Why should we? None of the bureaucrats and technocrats or foundations financing and thereby steering the UN have been elected by us. Hence, they haven't any legitimacy over what affects our daily lives in Switzerland. Furthermore, these plans have never been publicly discussed in Switzerland. Nor did we vote for them. And to be honest, we have meanwhile had enough of international organizations like the UN, the EU and the WHO undermining our direct democracy.

One (among several) potentially dangerous aspects of the Summit of the Future is the declaration of a “planetary emergency,” requiring a comprehensive global governance structure. The draft of the Pact for the Future speaks of the need for an “emergency platform” to be activated in response to global shocks, facilitating a coordinated, multidimensional response. This could have profound implications for national sovereignty and political independence. The UN aims to forge a global consensus to allegedly prepare for a future full of risks and opportunities.

However, do you believe that we will allow ourselves to be fooled again after the staged Corona pandemic?

Moreover, the Summit of the Future will also vote on a possible radical transformation of the UN itself, referred to as UN 2.0, and on how nation-states make decisions about the future of the planet. This essentially means the abolition of sovereign nation-states or reducing them to powerless entities. This is not in our interest. Especially, since it violates our federal constitution.

To make a long story short: your common agenda is NOT our common agenda. Our dialogue was non-existent. We oppose living in perpetual fear of orchestrated events that infringe upon our rights and freedoms. We reject digital enslavement and a tyranny through Artificial Intelligence. We are well prepared for the future that awaits us. We have learned a lot in recent years. Many of us have woken up. Not in UN's favour, of course. Anyway, we do not require the United Nations. Certainly not to survive on this planet. On the contrary: without the UN and its plans, our survival seems to be much easier and more likely and, above all, in any case more pleasant and human.

Please do not take our words personally. Perhaps as a father and grandfather you also have a different view of things in your private life. We would certainly wish for that.
